CAEP Accountability Measure 1 (Initial): Completer effectiveness. (R4.1

The SEPS Completer Satisfaction Survey (44 items) was administered to completers of our initial licensure programs in Elementary Education (1-6), Secondary Education (7-12) and K-12 programs in fall 2023 and spring 2024. The survey was distributed to over 1,236 completers in both the initial and advanced licensure programs with a low response rate of 3.4%. Notwithstanding, we consider the data we obtained to be helpful in our effort to inform and improve our licensure programs and the revision of the survey for fall 2024. Partial survey data from 42 respondents (27 from initial licensure programs and 15 from advanced licensure programs) are shown in the table below.
