### Dean's Office:

- **Thank you to Jeremy and all his support with CTEN this year. Welcome Kara Mulcahy and thank you for stepping up for the Fall. Kara is going out on sabbatical in the spring next year. Please keep that in mind.**

- PE only department to lower cut score for edTPA, lowered cut score 37 to 34.

- **Legislative update:**

Two bills before the Education committee, moving through House, bill 5436, this is an act concerning teacher certification Dr. Talty sat in on this, bill very complex lots of parts. Highlights of that bill are to repeal old certification statutes, some are no longer appropriate, some regulations contradict each other. The council needs to clean up the pieces that don't make sense anymore and that prohibits candidates from becoming teachers. This will eliminate if it passes the 3-tier certification system. We would go from initial provisional and professional to just Initial to Professional now. The feeling was provisional was not really needed. Alot stay at the provisional level forever.

Things that will impact us as Ed Prep program involve whether candidates need a master's, Paula gave testimony not in support of which is candidates do not need a master's degree to maintain the teacher certification. I feel that this de-professionalizes our work and I feel that candidates should have an advanced degree. This will affect all of us. If this goes through, we need to start thinking very creatively to help teachers maintain their skills and abilities.

Getting rid of outdated endorsements. No longer do middle school endorsements 4-8.

Another active piece, elimination of Praxis II, particularly at elementary teacher level where teachers are taking 4 tests. Also talk about considering secondary level as well. One concern one of the other Deans raised was would we determine sufficient content understanding and knowledge. More discussion about this. The biggest thing, control and advisement over certification will move to a standards board in same way as the medical board and the legal profession has the bar. This would be a standard board comprised of professionals and teachers who would make recommendations for legislature on areas of certification and regulations. Paula will share updates on these bills as they come out.

2<sup>nd</sup> bill senate bill 363, this would call for the elimination of edTPA as a graduation requirement. Right now, the state cannot hold up certification if they have not passed this. A section of this bill would state that we could use edTPA as an accountability tool for accreditation, but we cannot let this hold up completion of the program if they fail. When might we hear about this? Both bills at this point are significant. Paula thinks the edTPA one will take off. There will probably be some adjustments around 5436, particularly around the sunseting the Praxis and implementing phases into that bill. We should hear right after July 1<sup>st</sup>.

Significant legislative support Senator McCrory and Representative Curry are both championing this bill.

- **MAT** – Very pleased in process the work is exciting and there is a wonderful re-design ready to go. Will share with the larger design team next week., hoping to push this through curriculum in the Fall.

**Donna DeCarlo** – Big highlights to MAT, Current MAT program is 49 credits if all checks out, we are looking to reduce to 41 credits. Another big piece of it is as of now the current MAT program as it stands students are enrolled in about 15-16 credits during student teaching semester, which is wild causes a lot of burnouts, we are looking to reduce that as well, possibly down to 10 or 11 credits. The overarching thing is that we are making changes that benefit the students. Once the bigger committee meets next week makes changes and it's a go it will be shared. We will be adding TESOL to this as well.

- Teacher residency received Buck Foundation funds to do a build around a teacher residency for Para educators who hold a four yr. degree. Megan Mackey was instrumental in making this build happen. There will be an additional grant application to Buck of about \$400,000 for the next two years to do a build for a para educator pathway for those who do not have a 4 yr. Degree. Pathway 1 is starting this summer; we already have folks interested. Ed advance is planning on sending their para educators to us. Teacher America candidates already have an undergraduate degree, strongly vetted. We have entered into an agreement with them, and we will be their provider for all their teacher candidates. This will bring more students here to CCSU.
  
- **CAEP Update, Carol Ciotto**
  - Thank you to everyone from our CAEP lead teams and all the work you have done, thank you to all the faculty that have attended as well. We made a lot of progress this year with our work. It is making an impact with our AFI getting us to a place where moving forward things will be much more seamless and easier for us to implement. This will be better for addressing and analyzing data and making improvements. Data dinners and workshops have gone very well, and I am happy with the attendance. We will be implementing our first revised program assessment report due on May 31st, which will give us our first round of data for content review of standard 1. Helen and I will spend time over the summer reviewing those and looking at trends to set goals and objectives for the upcoming year, with regards to our AFI's and Standard 1. We are in a good place and look forward to what is to come in the upcoming year. Thank you again for all the work and commitment that everyone has provided. Jerney thanking Carol for all her hard work and commitment as well. Carol apologizes for overloading your plates knowing you are all very busy. The hope is that this is one and done and that it will be easier as we move forward.
  
  - SL&L - Thank you to Jen Tine who has done a tremendous amount of work to get us where we are at this point. This is a huge lift she has done so much work to get this up and running and she will continue to do this because we keep asking her to do things. As we migrate over from Taskstream to SLL I think the platform will be very useful to all of us. More user friendly, more things at your fingertips as a faculty member. You will get to build design and run your own reports, this way you won't be waiting on others for this information. Please know Jen will be available in the Dean's office as our point person. We have gone through our own training as well. We had an Early Adopters pilot who is piloting through the end of the semester, and we thank them all for stepping up and taking this on. At the end of May we are inviting the various programs to join us for a training. If you have not responded yet to us, please do, so we have a head count. We would like as many faculty from your departments to be there for this training. I will be sending another reminder out today. The full rollout will be in the Fall 2024. Tan Leng asking about key assessment in SLL overall goal is yes for key assessments, but the goal is also to have all assessments in this platform. Also to have a platform to house assignments, and eventually e-portfolio. Absolutely the first assessments you build will be key assessments. Donna – New students' coming in will be using SLL for the first time, Donna and Barb will be going to training on building applications. Donna will be forwarding to the faculty anything they need to know about the application.
  
  - Informational emails will be sent out to the faculty regarding the SLL process and how it will happen.
  
  - The goal of SLL is for accreditation and for annual assessment reporting, but also to give you and students a platform for everything.
  
  - Exercise science will be allowed to use Taskstream through the summer months to get through the application process. Moving forward they will need to purchase what they will be using because SLL has been purchased through the School of Education.
