Full-time Student Status.

An undergraduate student who registers for **twelve (12) credits or more** is considered a **full-time student** for tuition purposes. A graduate student who registers for **nine (9) credits or more** is considered a **full-time student** for tuition purposes, with the exception of Data Mining Majors*.

Full-time students are charged the tuition and fees established by the Board of Regents for Higher Education. Full-time students who fall below the minimum course load required to maintain full-time status must change their status to part-time. Part-time charges will replace full-time charges and any money that has been paid will be transferred to the new charges. Any excess payment will be refunded according to University refund policies.
